Privacy Policy

Collection, Use and Disclosure of Personal Information

"Personal information" is information about an identifiable individual, for example, your name, address, telephone number and other similar information. Any personal information collected, used or disclosed by *green oasis services inc.* through this website, if any, is subject to and managed by *green oasis services inc.* according to the Freedom of Information and Protection of Privacy Act (Alberta). This means that:
